The meeting was called to order at 7:37 pm by President, Tammy Rosato.

Tammy shared that Wilshire Division reports violent crime is down but property crime is up. Everyone needs to protect their automotive key fob from hacking and not leave any valuables in the car. A crew from Oakland has been apprehended resulting in a slowdown of crime.

2019 GREATER LOS ANGELES HOMELESS COUNT

Highlights from results:

58,936 County of Los Angeles --- a 12% increase

36,300 City of Los Angeles --- a 16% increase

72% of Prop HHH funds are committed to build 5,303 units

Approximately 1,400 units scheduled to open in fiscal 2019-20

10,000+ units in the pipeline (committed with projected funding)

800+ Outreach staff with expertise in physical, mental health and substance abuse

Veteran homelessness slightly decreased

Families experiencing homelessness increased 6.4%

Youth homelessness increased 24%

Senior homeless increased by 8%

Majority of people experiencing homelessness have lived in LA County over 10 years
